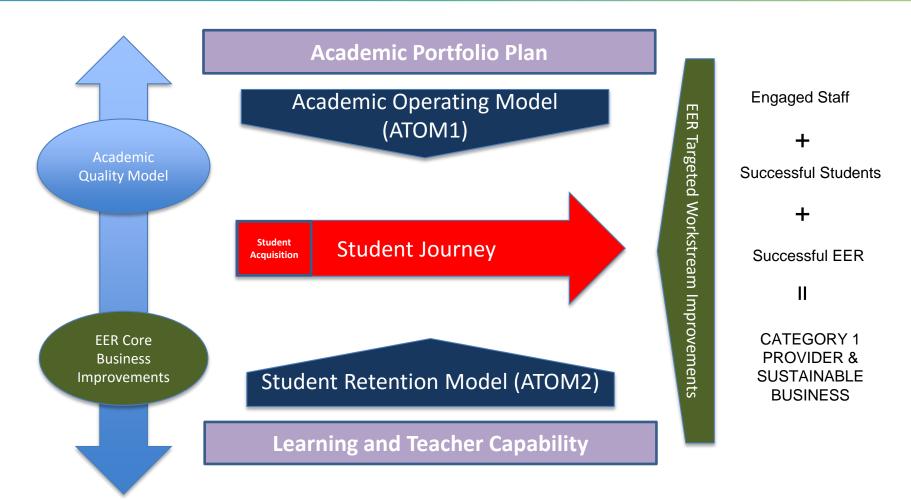

CORE BUSINESS IMPROVEMENTS

The Core Business Improvements are underpinned by the following key initiatives:

- Academic Quality Management System Unitec's QMS and associated business units need to be reshaped to meet current organisational needs and the expectations of a Category 1 provider.
- Academic Data Warehouse and Dashboard this will establish a repository of accurate and actionable data that will be used by Academic staff during their self-evaluative practice; this will lead to more robust decision-making, improved action planning and a better student experience.
- Academic Stakeholder Engagement Approach this will scope and a define an institution-wide approach to academic stakeholder engagement, ensuring that all Unitec programmes have an authentic and sustainable link to the industries that we serve, and the employers and communities of our students and graduates.

SUMMARY OF OVERALL PERFORMANCE AND PROPOSED ACTIONS

The Practice Pathway is on track to achieving a Confident/ Highly Confident rating Educational Performance and Capability in self-assessment. It will benefit from data being available to better track Valued outcomes' for its learners. Main concern is the nature of bridging programmes and associated performance metrios. Work needs to be done to better benchmark against like-for-like sector programmes.

Staff engagement and academic compliance activities are exemplary. Student NPS feedback continues to be very positive, and is consistently one of the highest of any Pathway across United. 2017 Team Diamond and Annual Business Plan complete, with 100% of all staff across the Pathway completing an ADEP plan for 2017 that is connected into the KPIs/ EPIs of the Annual Plan. This is an organised and well-performing Practice Pathway.

RISKS and ISSUES

Wider United Transformation i.e. change management, application to enrolment processes, new timetabling programme, and student experience/ services on-going support. Students face a range of socio-economic factors leading to the inability of some to succeed. Moreover, these issues are worsening - and we are not trained or resourced to adequately deal with the multiplicity and complexity of what can be insurmountable obstacles for our students. Significant increase in student mental health issues over the past 24 months.
