### Recommendation

  - 3) Auckland South Mangere: Al Madinah School
  - 4) Auckland West Point Chev: Point Chevalier School
  - 5) Christchurch: Hornby High School
  - 6) Hamilton: Hillcrest High School
  - 7) Hawke's Bay: Havelock North Primary School
  - 8) Invercargill: James Hargest College
  - 9) Marton: Rangitikei College
  - 10) Masterton: Rathkeale College
  - 11) Motueka: Motueka High School
  - 12) New Plymouth: Sacred Heart Girls High School
  - 13) Ngatea: Hauraki Plains College
  - 14) Rangiora: Rangiroa High School
  - 15) Tauranga: Aquinas College
  - 16) Wellington: Scots College
  - 17) Nelson: Nelson College.
- 2. That Academic Board notes the following temporary site for the delivery of the Master of Contemporary Education by The MindLab by Unitec:
  - 1) Rotorua: Rotorua Boys High School.

## Background and Justification

Since mid-2015, The Mind Lab by Unitec (TMLU) has been partnering with schools across New Zealand to establish temporary delivery sites for the Post Graduate Certificate in Applied Practice (Digital & Collaborative Learning) (PGCAP-DCL). There has been an agreed process with NZQA for the notification of these temporary sites. We now have the opportunity to establish new temporary delivery sites for the delivery of the programme at the above locations. With the recent approval of the Master of Contemporary Education (MCE), TMLU wishes to extend the same model for delivery through partnering with schools. NZQA were consulted and have advised a similar process for notification of temporary delivery sites for the MCE, as long as the programme is delivered to only one cohort per temporary site. If TMLU wish to deliver the programme to additional cohorts at any temporary site, site accreditation will need to be sought. Note that the Rotorua temporary site proposed for MCE is actually an existing temporary site for the delivery of the PGCAP-DCL, but a new MOU has been written to enable the delivery of the MCE.

### Next Steps

Following Academic Board endorsement, a notification and relevant documentation for each of the listed sites will be through to NZQA as per the established process.
