### Rationale:

The student 1443099 was dropped from HSDV5145 – class #2470 as part of 1182 no show process. She attended classes and completed assessments. She has passed the course upon resubmitting an assignment. However, she was not enrolled into the course due to a Unitec system that was at fault of tracking the results of this student.

### Mitigation Action:

- Consultation has occurred with Academic Leader from HSDV who identified where the error occurred (systems error)
- Liaised with Edgar Rowland (Team Leader Academic Administration) who advised approval from Executive Dean (Merran Davis)
- Liaison with Barbara Jacomb (Manager Graduation Registry) in regards to graduation once approval from Executive Dean

### **Prevention measures:**

- TKK has reviewed this occurrence and identified some areas where clarity of process was required.
- From this, TKK commits to:
  - o Ensuring that the initial check of the potential graduate list is cross referenced with the eligibility to graduate list; and
  - o Support processes are put in place for training in this area
