7. Update on Short Course, Training Scheme, and Vocational Pathway Procedure AC 1.3

The chair opened the floor to discussion surrounding the above mentioned procedure. The chair gave an overview of the types of courses and schemes Unitec offered across the spectrum.

Discussion focused on whether the AC 1.3 procedure and associated Short Course/Training Scheme/Vocational Pathway proposal form required any additions, deletions or changes and, were the definitions of these offerings widely known?

Steve Marshall and Rakesh Patel will work together to ensure that the new application form has information that encompasses all requirements for NZQA.

The chair will investigate who approves proposals for short courses, training schemes prior to the application being submitted. In essence, what is meant by "Endorsed by Senior Leadership".

Te Korowai Kahurangi informed the committee that the majority of short courses cannot demonstrate that they have met the requirements outlined in the policy and procedure and have very little or no paperwork associated with them (i.e. course descriptors). Training schemes were regarded as being fully compliant.

It was agreed that the committee would advise Academic Board to commission an urgent review of short courses to establish the following:

- All short courses that are currently active in the system are still being offered, are fit for purpose and therefore should remain active;
- All short courses that are currently active are aligned to the correct category;
- All short courses on offer are compliant with regard to required paperwork;
- All short courses on offer are compliant with United policy and procedure with a focus on quality assurance.

The committee offered to establish a working party to undertake any commissioned review on behalf of Academic Board.

Dila Beisembayeva requested a list of all the short courses be sent to the Academic Programme Managers so that this reconciliation can occur, following approval of a review by Academic Board.
