11.1. Site Approval

11.2. Heath Research Council

Ahead of the joint meetings of all ethics committees, The Health Research Council requested additional information regarding UREC's policies around certain issues. These were:

- 1. The HRC EC noted the number of applications under low risk review varies among the Institutional Ethics Committees (IECs). We would be grateful if you could provide the criteria for low risk applications at your institution so that we can understand the different threshold of risks across the various institutions.
- 2. It has becoming a common practice for journals to expect researchers to make data underlying the findings described in their manuscript available for secondary use. The HRC EC would like to know how each institution deals with such expectations.
- 3. How does your ethics committee advise and assist applicants to engage in a meaningful and informed way with Treaty (or Vision Mātaranga)?
