Recommendation/s

That the Ako Ahimura Learning & Teaching Committee receive the TCD evaluation, note additional information below and provide feedback on the discussion points below.

Additional Information

- The Director of Ako provided advice, at a September meeting of ELT, on the risk of United not achieving our goal of two 'badges' per teacher in 2019. The following recommendations were agreed:
 - That ELT support the Director of Ako's request of Heads of School for a planper-School to achieve the targets (as recommended by the Learning & Teaching Committee in July)
 - 2. That ELT agree on any circumstances in which non-achievement of targets is acceptable, e.g. by negotiation with individual Heads of Schools, taking into account their specific School circumstances.
 - 3. Taking into account any inconsistencies arising from 2 above, that non-compliance by teachers is recognised in the ADEP review process.
- Te Puna Ako will collaborate with Te Korawai Kahurangi to ensure that mechanisms for measuring impact of engagement in TCD on the organisation and on student success are embedded in current evaluative systems (CEP and PEP for example).
- Director of Ako is working with HR to embed the Teaching Competency framework into Unitec's recruitment, development, and progression processes.
- Te Puna Ako and Director of Ako will commence a positive messaging campaign highlighting development benefits and positive impact of engaging in TCD digitalcredential.
- Mandatory PD digital-credential requirements for 2020 have been agreed:
 - · Teaching staff: to complete 2 badges, 1 of which must relate to parity targets. LivingTe Noho Kotahitanga badge will be included in the suite of optional badges for parity targets.
 - · Non-teaching staff: to complete 1 badge relating to parity targets. This should be the *Living Te Noho Kotahitanga* badge unless already completed, in which case another badge from the *Te Rito* suite may be selected
- Te Puna Ako and the Learning & Development team will work with APMs to enhance understanding the intent of TCD approach and suite of offering with the aim of guiding better development (as opposed to compliance) plans for the 2020 ADEP round.
