3. Matters Arising

3.1 Review of Short Courses - Update

Steve Marshall gave an update about the short course review and made the following points:

- After reviewing in PeopleSoft there are approximately 60 short courses to be retained, down from approximately 440.
- The short courses need to be reviewed to assess whether they are training schemes or short courses. The documentation will also need to be reviewed to ensure that it is up to date.

The chair advised that the difference between short courses and training schemes are that short courses are not assessed and there is no certification whereas a training scheme is similar to a small programme.

5. Introduction to Police Studies Aotearoa New Zealand (Training Scheme)

The committee discussed the application and noted the key points of the discussion were:

- There was a lack of specificity around the purpose statement. The purpose statement is very broad when it seems like the purpose of the Training Scheme, is quite specific (i.e., to allow entry into Police College).
- Also noted was a misalignment between the purpose statement and, in particular, the third learning outcome which appears to be inordinately large and, at a higher level than would be expected of a Level 4 course, especially when it is stated that the intent is to deliver 'foundational' knowledge.
- There needs to be clarity around the use of the term "face-to-face" as this is an online course

- Lack of clarity around consultation in so far as there was no evidence of support from the key stakeholders to inform the change.
- There was concern around the learner profile (i.e., target market) which was absent in the document.
- Questions relating to capability of resources given that legislation, case law and application were being taught.

A more detailed description of the above points have been captured on the evaluation form.

Upon further discussion, the committee agreed to invite the programme development team to discuss the above points. Katie Bruffy and Darren Tolmie arrived at 2.10pm.

Following discussions with the programme development team it also became apparent that there was no structural change to the course.

The committee members agreed that the document could not be approved in its current state.
