Overview

General Committee Health Check

What is going well?

- 1. Success and retention rates continue to be high and maintained.
- 2. Stakeholder communication (internal and external) is good and feedback is used to inform programme developments as required.

What improvements can be made?

- 1. Additional communications to students about external monitor visit outcomes.
- 2. Formal capture of how well MI graduates are prepared for the workforce.
- 3. Greater embedding of Mātauranga Maori within the programme
- 4. Increased computer lab availability at Waitakere

What support is needed (actions required)?

- 1. APM to summarise external monitor outcomes and make available to students
- 2. Development of graduate survey for alumni and stakeholders (clinical managers/employers) through Industry engagement team
- 3. Staff require support to successfully encapsulate Mātauranga Maori within their courses
- 4. Increased lab space or at a minimum support setting up temporary labs as required.

Progress against 3 (max.) key actions

- 1. External moderation plan- completed for 2019.
- 2. Level 5 Teaching qualifications for some staff- ongoing; first papers completed.
- 3. Graduate survey data- under way with Unitec Industry engagement team but not completed.

Priorities (3-5) for cycle

- 1. Progress on 2019 external monitor report actions:
 - Further development of blended models of content delivery.
 - Retention and succession planning discussion, to support ongoing stability of the programme
- 2. Preparation for programme review and external monitor audit.
- 3. CEP activities for start of semester 1 teaching.

Risk management

Risks to the programme at the time of MIPAQC meeting on 10-03-20 were identified as low across all categories. Continued management and review of risks will determine whether these are likely to change and the strategies required to minimise any impact.
