# 2.1. Applications for Programme Approval and / or Accreditation

Members noted a technical issue with Apple Mac users accessing the application content on OneDrive.

# 2.1.1. New Zealand Certificate in Business (Accounting Support Services) – NZACC

Level 4; 50 Credits

NZQA Reference Number: NZ2455

Members noted that:

- Version 2 of the outcomes should be used instead of Version 1, when the revised qualification has been published.
- Unitec has an entry requirement policy which differs from the MIT policy of "no admission requirements for domestic applicants". School of Applied Business had agreed to go with the MIT policy, however further consideration was needed at an institutional level.
- If Unitec adopts "no requirements", then we would need to build support to assure success for all applicants regardless of education level.
- The Key Information for Students entry requirements are a summary of the actual Entry Requirements. Further discussion shall be had between Rakesh Patel, Steve Marshall and Jackie Tims.
- Concerns exist as to whether Unitec can actually deliver on the HyFlex model from MIT. However, the School believes they can, so the members accept this.
- HyFlex Model and Work-Based Learning Intentions of the School and the obligations of students, workplace and Unitec were unclear. ACTION (to be tracked)
   → Quentin Williams (Te Puna Ako) to engage with the School on the implementation of the MIT HyFlex Model within Unitec to support as well as to capture any lessons learned for Unitec.
- Version checking and recent update of materials to be checked. ACTION → Jackie
   Tims is to follow up with Antoinette Wessels to ensure materials are up to date.

The committee was interested to see the School and Te Puna Ako Advisors work closely to ensure that "learnings" from the delivery of the MIT model/s are spread across the institute. In theory, the model/s sounds interesting, but needs to be successfully realised through effective collaboration.

From the discussion, a number of conditions were placed on the approval Motion. These are recorded in the Motion below.

#### **MOTION**

New Zealand Certificate in Business (Accounting Support Services) – NZACC

- Programme documents be aligned with any possible updates from MIT.
- Standard United entry requirements apply. If there is a wish to revisit 'open entry' then broader discussion will be required across institute.
- Factual Summary be aligned with MIT information, with an exception on the Entry Requirements noting that United does *not* move to 'open entry' but that standard United Entry Requirements apply.
- Factual Summary Change delivery to Mt Albert and Waitākere.
- Work Experience Option Work with Quentin Williams (Te Puna Ako) to clarify the support, oversight, intent, optional status, arrangements for online learners and delivery hours of work experience.
- "100% Portfolio" Work with Quentin Williams (Te Puna Ako) to check that this adheres to the MIT protocol.
- Te Tipare; Poutama; Mātauranga Māori; Pacific The School of Applied Business
  utilises and engages in the principle-based practice of these ensuring that they are fully
  incorporated in the teaching and learning aspect. It is an integral part of Unitec. Our
  professional development package (Badging System) is set up to ensure continued
  engagement.
- Confirmation from the School that the Letter of Intent notes that MIT supports the use of their materials until Unitec develops and receives NZQA approval and accreditation of its own materials. (For further details, contact Jackie Tims.)
