



Dashboards to access for answering Key Evaluative Questions

KEQ 1: How well do students achieve?

Two particular Dashboards to visit for this KEQ are:

- **01 Student EPI Dashboard TEC Data.** Three times a year, in January, May and August, Unitec submits our data *from the year before* to the Tertiary Education Commission. They publish it nationally, we collect that national data and refresh this Dashboard. The Educational Performance Indicators (EPIs) are: Successful Course Completion; First Year Retention; Qualification Completion; and Progression. You will need to be able to speak to these. You can find out results for priority groups as well as all students, and by age group, gender and full-time/part-time study. - **02 Live Data Dashboard.** This collects internal Successful Course Completion (SCC) results as final grades are submitted into PeopleSoft. It is refreshed every day. You can view the data at School, Programme and Course level, using the filters available, and also check SCC for all students and for each priority group. You can also compare trends over time. KEQ2: What is the value of the outcomes for key stakeholders, including students?

A key Dashboard to visit for this KEQ is:

• **04 Graduate Dashboard.** This provides the data from the Unitec Graduate Survey. It is collected from surveys conducted in November and April for a given year (ie responses from students finishing mid-year who graduate in October plus students finishing end-of-year who graduate in April).

Note: Information from Consistency Reviews, Industry Advisory Committee meetings and other qualitative evidence collated by the School/Programme is particularly useful here.

KEQ3: How well do programme design and delivery, including learning and assessment activities, match the needs of students and other relevant stakeholders?

Two Dashboards to visit for this KEQ are:

- **03 Student Course Surveys Dashboard.** This provides the results from the Student Course Surveys conducted each semester. They particularly ask for feedback on course content, course teaching, course assessments, and practical components.
- 11 Research Dashboard might be useful. Note: it operates at School level.



KEQ4: How effectively are students supported and involved in their learning?

Three Dashboards to visit for this KEQ are:

- 03 Student Course Surveys Dashboard.
- **07 Student Support Services and Library.** (This Dashboard is being developed. Twice a year data on usage of Academic Development Lecturers, Library, Careers Guidance and Counselling is uploaded).
- **08 Student NPS Dashboard.** This gives the results of a twice-yearly survey asking students about their experience of Unitec. There may be some notes to glean from this.

KEQ5: How effective are governance and management in supporting educational achievement?

Two Dashboard to visit for this KEQ are:

- **08 Student NPS Dashboard.** Giving student perspectives of their experience of Unitec.
- Academic Risk Dashboard. Check out the tabs titled 'Programme Risk Matrix' and 'Programme Risk Detail'.

KEQ 6: How effectively are important compliance accountabilities managed?

There is a project begun to build a Dashboard monitoring compliance accountabilities being met by drawing upon information from PAQCs. As of May 2020 this is still being scoped.
