Overview

This PAQC has had two meeting since the Level 4 Covid-19 shutdown of the institution. This report covers the second quarter of the current academic year

General Committee Health Check

What is going well?

Quorums were achieved at the two meeting .
Student representatives attended and contributed
Steve Marshalls attendance was invaluable as was Riza Aguilar

What improvements can be made?

A few issues that were noted in the PAQC meeting can be added to the Chair's report to QAB, e.g. students at risk, graduands/employers survey for consistency review process, and resourcing issues for increasing student numbers.

Students at Risk

- Student Performance data will place a flag on the students "at risk", while teaching staff may not receive enough information to understand the situation well to support the "at risk" students.
- Student Rep commented that most students who have problems do not know where to go and who to talk to.
- Suggested actions: Regular teaching staff meetings to address, share and record the students with learning disabilities or wellbeing issues; A formal system in place for tracking and reporting; Approach LOP (Learning Outreach Person) in Student Success to bring the assigned LOP to school specific orientation for students to familiarize the support services available at campus; Refer students to campus counselling services for mental support; These issues and activities are included in the Chair's report to QAB.

Risk Register BI

- Risk register needs to be updated first week of every month to reflect the live data for risk management.
- A formal request to HOS for arrangement of the person responsible for updating the risk register in BI for Sandra A.
- Understand and interpret the data: Steve cited the example of declining EFTS in the programmes that would trigger investigation and analysis for the reason (e.g. industry shut down due to COVID); Sue cited the fees-free programme that increase the EFTS but the risk would be the school is not resourced for it.

Employers and graduands profile:

- The school is connecting with industry via Industry Advisory Committee to address how the programme learning outcome will fit into industry requirements.
- Concerns on how we conduct graduate and employer survey to gather more feasible feedback (e.g. survey held 6 month and 12-month post-graduation) will be addressed in the Chair's report to QAB.
- TKK is working on pooling all the programmes and staff who have been through the consistency review to gather feedback and project how the schools can be better supported during the process.
- TKK is working on the formula to project the next consistency review date for each Level 1-6 programme.

What support is needed (actions required)?

The Risk register is still a work in process . With the absence of Sandra Arnet responsibility for completing the risk register has been picked up by the HOD, Pete McPherson

Progress against 3 (max.) key actions

1. A member from another discipline has yet to be selected as an additional member of the PAQC .
2. The MLA/MARCH and NZCLD & NZDI5 PEPs have been completed and sent to QAB and sent to NZQA. The NZDL and the expired DID PEP's are completed and have been submitted to the QAB and sent to the NZQA.
3. Continued discussion on the preparation of the PAQC work plan for the year.
