#### Overview

Two regular meetings of the BN PAQ committee have been held (28 April & 9 June). Both included attendees joining either face to face or via Zoom. Sub-committee meetings have been held for ratification of grades and to consider special enrollment circumstances.

Two student representatives have now been appointed to the committee and we look forward to welcoming them at our next meeting on 18 August.

# **General Committee Health Check**

# What is going well?

The committee is working well to achieve its purpose to ensure that quality assurance and continuous improvement for course and programme quality and outcomes for students, comply with Unitec-wide policies, processes and procedures, while providing the formal forum for self-assessment and academic decision making by Academic Programme Managers and Teaching Staff.

#### What improvements can be made?

Going forward we hope to make better use of sub-committees to help us further enhance our quality processes. For example, a sub-committee to review all MyCourseDetails for accuracy in relation to Course Descriptors and for consistency of presentation and content across the programmes to increase clarity for students.

# Progress against 3 (max.) key actions

No specific actions nominated last cycle due to urgency of COVID response. Managing implications and potential implications of COVID on student success and achievement remains the highest priority.

During this period we have worked hard with colleagues within Unitec from TKK, ADU, etc. and our clinical stakeholders to mitigate impact on students of the pandemic. The APM has been pivotal in this as course completion dates have had to be extended due to ongoing repercussions of the unavailability of clinical placements during Levels 3 & 4 lockdown (see risk section below for further discussion).

# **Priority Group Strategies**

#### **Process**

Staff are committed to embedding I See Me initiatives. Specific processes in place include discussion of 'priority groups' being an agenda item for each staff meeting and PAQC meeting. For example, grade ratification meetings include discussion of the outcomes at each course level for priority group students. In addition, I See Me being part of orientation of new staff at the department level, and the continued work of our priority group 'champions'.



#### **Outcomes**

Enrolments remain stable for all students, including priority groups, despite COVID19. As noted in the June PAQC minutes, the COVID related online assessments went well.

# Risk management

## Summary

- No access to clinical placements due to lockdown level 4 and level 3 (covid-19)
  continues to impact on course completion. For example students in year 1 & 2 clinical
  courses in Semester 1 2020 will not have access to complete their clinical hours until
  December. Grades for these students/courses have been deferred with ARC
  approval.
- The pandemic remains our moist significant risk at this time. Future planning cannot specifically factor this in, but we realise that should there be a return of community spread of the virus our access to clinical placements may again be impacted. Such an event would compound existing deferrals and raise new ones.
- Usually at this time we are carefully predicting and booking the required clinical
  placements for the following year. This is alongside the Auckland DHBs and the other
  4 nursing schools. The closed access in Semester 1 (Lockdown levels 3-4) has and
  will have continued consequences to being able to deliver the programme. Planning
  to support the resolution of this situation is dependent on cooperation between all of
  the 5 institutions and DHBs.

# *Improvements*

Processes developed during the Level 3-4 lockdown in conjunction with our clinical partners and Health and Safety at Unitec in regards to student safety in clinical placement means we are now in a better position to respond should another lockdown be required.

# **Quality Reporting**

### **Student Success**

Grades and Completions

BNURS – only the Clinical courses (HCBN5106, HCBN6103, HCBN6107) are not yet posted for 1202. All have been approved by ARC with set extension dates.

VTNCA - All Posted for first intake 2020.

The deferred grades for courses listed above are COVID response related. Access to clinical placements for all students has been secured and providing there are no further limitations on access to clinical placements because of COVID, the BN PAQC is assured that these grades will be complete by year end.

Student success for all ratified courses will be discussed at the next BN PAQC meeting (18 August).

## Moderation

Moderation plans

Internal moderation has been completed for all semester one courses and pre-moderation in progress for Semester Two, as per BNurs regulations. External moderation will occur for seven courses (as below) in late August or September.

- BNURS Seven courses (HCBN6101, HCBN6102, HCBN6103, HCBN7101, HCBN7102, HCBN7103, HCBN7104) due for external moderation during 2020
- BNURS Seventeen courses were internally moderated for semester one 2020.
- VTNCA moderation completed for first intake 2020



### Moderation outcomes

### **Student Evaluation of Courses**

Summary of response rates for programmes –

The committee would always prefer higher response rates, but we are satisfied with an overall rate of 44.9%.

Summary of issues and improvement plans

Survey results are being reviewed by the BN team. BN PAQC has not had a scheduled meeting since release of the surveys.

## **Course Evaluation and Planning**

Engagement: All staff are involved in this process as either course co-ordinators or lecturers within courses.

Most CEPs for Semester 1 have been completed and include documentation to support that internal moderation has occurred. Some are not yet completed where courses have had an extended completion date that means staff are completing teaching and admin for Semester One courses while preparing and teaching Semester 2 courses. BN PAQC will monitor completions over the next few weeks.

# **Stakeholder Engagement**

**Process** 

Throughout the COVID19 Levels 4, 3, and 2 we had frequent Zoom meetings/phone calls etc. with many external stakeholders within the Ministry of Health, District Health Boards, Nursing Council, and other nursing programme providers around the country as we reacted to the evolving situation and its impact on the learning and course completion for our students across all three years of the programme given that access to clinical placements was not possible during Levels 4 and 3, and in some areas (e.g. mental health) even in Level 2.

Next **Nursing Advisory Committee** meeting with our external stakeholders scheduled for 15 October 2020.

**Awhina Strategic Advisory Committee** meetings have been held (3 March and 2 June). Next meetings scheduled for 2 September and 9 December.

#### Outcomes

The course completion date extension requests (approved by the ARC as noted above) were as a direct result of conversations with our stakeholders and regulatory authorities (as above). As a result we have been able to provide support and clinical access for our final semester year 3 students to enable them to complete the programme and be eligible to sit the NCNZ State final exams on July 21.

#### Research

To be discussed at next PAQC; scheduled for 18 August 2020. This will include a presentation to summarise current studies underway in the department, and discussion of where newly appointed staff are on their research journeys and what support they might need to progress their research.
