
September 2020 Academic Risk Summary

This report provides data from the 80 programmes that have been rated on 14 risk factors¹ based on updates submitted by APMs at or before 7.30am on 8 September 2020.

Institutional Risk Summary

The distribution of risk factors across all 80 programmes shows that 52% are rated low, an increase of 2.4% over the last update, while 9.7% are rated either high or extreme which is 0.6% lower than last month. At the school level, as in the previous updates, risk is low for Creative Industries, Healthcare & Social Practice, Applied Business and Bridgepoint while Community Studies continues to show the highest level of risk at 19%.




The areas that receive the highest risk ratings across all programmes include:

- 1. EFTS continue to decline and no improvement in revenue streams (26.3% rated either high or extreme risk).
- 2. Programme targets not met (13.8%).
- 3. Programme does not have sufficient resources (teaching spaces, consumables) to support delivery (12.5%).

¹Some programmes are not rated on the following two risk areas, so these two have been removed from their risk registers.

- External requirements not met (i.e. Regulatory / Professional requirements)
- "Level 7+ programmes: Quality and quantity of research is insufficient to meet statutory requirements and contribute to student success"

4. Staff capability and/or capacity does not meet learner needs / Assessment is not effectively managed/validated or does not ensure achievement of outcomes (11.3%).



Level 7+ statement is currently under review so is not highlighted as a top risk for this report.


Key Risk Areas

1. EFTS continue to decline and no improvement in revenue streams (26.3%)

- 26.3% of all programmes are rated either high or extreme risk, an improvement of 3.7% over the previous update and 5.8% over a 2-month period.
- Schools with particularly high risk include Creative Industries (60%), Architecture (55.6%), Applied Business (30%) and Computing, Electrical and Applied Engineering (30%).
- The risk decline was mainly driven by Building Construction and Community Studies which show an improvement of 14.3% and 28.6% respectively over the last update.
- The high risk rating is driven primarily by those programmes with traditionally high numbers of international students.

Recommendation: That QAB note that:

- APMs and Heads of School have been requested to determine whether individual programmes can be delivered online to offshore students in 2021 and that a process is underway to seek relevant approvals to do so.
- Te Korowai Kahurangi is investigating ways in which risk ratings for this risk areas can be analysed against programme EFTS targets to gain greater assurance regarding this risk.




2. Programme targets not met (13.8%)

- 13.8% of all programmes are rated either high or extreme risk, unchanged from last month.
- Community Studies remained at the top with 42.9% of their programmes rated high or extreme in this area, followed by Computing, Electrical and Applied Engineering (30%) and Creative Industries (20%), all unchanged from the previous update.
- Applied Business has seen an increase by 10% to 100% of its programmes rated low in this risk factor.

Recommendations: That QAB note that an action was placed on the PAQCs listed below following the August 2020 Academic Risk Summary report. No responses have yet been received.

- Community Studies
- Creative Industries
- Computing, Electrical and Applied Technology




3. Programme does not have sufficient resources (teaching spaces, consumables) to support delivery (11.3%)

- 12.5% of all programmes are rated either high or extreme risk, unchanged from the previous update, but a decrease by 1.5% over a 2-month period.
- Creative Industries continues to have 80% of its programmes rated high or extreme
 in this area, followed by Computing, Electrical and Applied Technology with 30% of
 its programmes being rated high, both unchanged from the previous update.

Recommendations: That QAB note:

- there was action from the previous report regarding the closure of teaching spaces in the northern campus and that assurance has been provided by the Executive Director, People and Infrastructure.
- That PAQCs have been requested to report assurance to QAB in the next PAQC Chairs' report on the high levels of risk in the following Schools (for programmes with High or Extreme ratings):
 - Trades and Services
 - Computing, Electrical and Applied Technology




4. Staff capability and/or capacity does not meet learner needs (11.3%)

- 11.3% of all programmes are rated either high or extreme risk, improving by 1.3% from the previous update.
- In contrast, Community Studies has improved by 14.3%, with 42.9% of its programmes rated in high or extreme risk in this area.
- This is followed by Computing, Electrical & Applied with 40% of its programmes rated high risk, unchanged from the previous update.

Recommendations: That QAB note that assurance has been sought from PAQCs in the Schools listed below that this risk is being effectively managed:

- Community Studies: (BASHB, NZCEX, NZDSR)
- Computing, Electrical and Applied Technology (BCS, GDCMP PGDCG, DCOMP)
- Trades and Services (NZCC, NZCP4)




4. Assessment is not effectively managed/validated or does not ensure achievement of outcomes (11.3%)

- 11.3% of all programmes are rated either high or extreme risk, an improvement of 1.5% over a 2-month period.
- Trades & Services is at the top with 54.6% of its programmes rated high or extreme risk in this risk factor.
- Applied Business has 100% of its programmes rated low in this area.

Recommendations: That QAB note the programmes listed below have either High or Extreme Risk ratings for this risk area and to:

- require an immediate response from the relevant APMs as to the rationale for these ratings
- require a response from the relevant PAQCs about what is being done to manage this risk in these programmes.
- Trades and Services (NZCCT, NZCC, NZCD4, NZCG4, NZCP4, NZCPG)
- Community Studies (BTECE)
- Computing (GDCMP)
- Building and Construction (NZDE)
