Responses from Members / Attendees

- We need a follow up session with David Glover. In future, this could be a bi-annual practice, prior to the first meeting of a new year and also at mid-year.
- Confidence growing, evidenced by more questions/critically in discussions
- Still a bit of work to do on clarity about what the member's role is, i.e. is it to represent and follow up on issues specific to their team, or is it to take institution-wide view?
- The organisation and structure of the meeting has improved greatly.
- Great to see the meeting finishing on time. It indicates that we are normalising again after prolonged disruption. Great effort by all. I find the online mode of hui extremely practical and functional.
- There has been a significant improvement in members understanding of how to read and analyse data, and how to apply a governance lens to the following:
 - Risk
 - Regulation, Policy and procedure
 - BI Data including success, priority group measures and initiatives associated with compliance reporting
- What I've noticed is that it's difficult to tell whether a question is more operational or strategic. I think this continual second-guessing can lead to participants choosing silence instead. This may be because they've been called out for being too operational. On the other hand, there are definitely times where conversations become very operational and sometimes lead down rabbit holes. However, these don't appear to be called out. I guess this will take time and think we need to find ways to manaaki everyone to understand if the kōrero is too operational, or whether it is appropriate for Te Kōmiti Mātauranga.
