Te Poari Whai Kounga noted that this item was a very late submission.

Te Poari Whai Kounga discussed the reporting and noted that:

- PAQCs are maturing in their understanding and performance of governance.
- PAQCs desire clearer direction from QAB.
- Systems and processes behind PAQC reporting and governance are improving iteratively.
- Consideration could be given to developing a dashboard that tracks much of the data needed for high quality governance of programmes, e.g. "Programme Academic Quality Management Dashboard".
- Areas of good practice exist where some programme teams have additional qualitychecking processes which add value to the CEP and PEP processes.
- Online CEPs are adding value through their transparency to other programme teams across the institute. Consideration is underway as to how this awareness can improve the quality of other programmes.
- Effective engagement of the institute with student feedback has been a challenge for over ten years. Student Council is investigating ways to gather more holistic student feedback, and to collaborate with MIT approaches in 2021.
