Recommendation

That Te Poari Whai Kounga approve the end-of-year 2020 Programme Evaluation and Planning (EoY PEP) as detailed in this memorandum.

Purpose

To provide Te Poari Whai Kounga with the opportunity to discuss the benefits and challenges of the process to support the EoY PEP for programmes and training schemes.

Justification

The Board should support the recommendations as the EoY PEP approach is:

- Flexible
- More programme-centric
- No radical changes
- Consolidates progress to-date
 - o evaluative writing has improved
 - o strengthen the use of rubrics
 - o benchmark against previous years, school targets and across sector
 - o judge more reliably, "What is "Excellent", "Good", Marginal" and "Poor"?
- Continue commitment to Āta-kōrero
- Some efficiency improvements

Background

Programme Evaluation and Planning is led by Manaakitia te Rito, our Te Noho Kotahitanga principles supported by Academic Committee and the Academic Evaluation, Review, and Improvements policy. In essence the process supports Unitec to manaaki the success of our learners and communities.

The overall purpose of the PEP is four-fold. To:

- monitor and improve performance in delivering positive outcomes for our students and other stakeholders
- monitor and improve our ability to reflect on the effectiveness of our actions in doing the above
- increase consistency in educational performance and self-assessment across the organisation
- report on educational performance and self-assessment capability to our key external stakeholder NZQA



Proposal

It is proposed the 2020 EoY PEP has the following scope, focus, timeframes, data and template approaches.

Scope

Schools will be provided with a full list of programmes, including those which have been excluded. Where a School wishes to vary what is proposed, this can be discussed with the Chair of Te Poari Whai Kounga.

In general, programmes will be open to exclusion based on the following:

- Less than 3-5 EFTS in 2020
- expiring due to 2018 Suspension of programmes
- expiring due to Mandatory Review of Qualifications

Timeframes

Generally, programmes have the ability to flexibly manage their own timelines provided the following are met:

22 November End of (standard) semester

23 November – 18 December Grade ratification and CEP completion

23 November – 23 April Āta-kōrero (timing to be decided by programme leaders)

i.e. Āta-kōrero in December may:

form part of grade ratification to evaluate KEQ 3, 4 and 5

address previous SMART goals

create and implement SMART goals in readiness for 2021
 Semester 1

8 February 2021 January SDR dashboard refreshed and available for KEQ 1 data and

further Āta-kōrero and PEP completion

15 February - 9 April Āta-kōrero continues in February to address January SDR

15 February - 23 April Recommended time for PAQC evaluation of PEP reports

23 April Deadline for submission of reports to qab@unitec.ac.nz

12 April – 1 May Selection of programmes reviewed for quality assurance purposes.

Programme Teams may be required to amend and resubmit their

reports

10 May – 21 May Te Korowai Kahurangi Evaluation of process of PEP cycle

30 June 2021 Submission of Level 7 and above PEPs to NZQA

Note: PEPs are to be used to inform School evaluative commentaries.

- Provision of a purpose built PowerBI dashboard for PEPs based on Peoplesoft dynamic data (for programmes to explain anomalies with EPIs based on January SDR)
- Data to be snipped and pasted from PowerBI dashboards by the PEP writer

Removing

- Requirement to fill in tables with numbers
- PDF files will NOT be provided except for GPOs and these will linked
