Recommendation

Purpose

The purpose of this paper is to provide Academic Committee with an overview of the mahi undertaken by the Committee in 2020 and a brief summary of the Committee's reflection on its mahi.

Commentary

Te Poari Whai Kounga terms of reference make the committee accountable for undertaking to:

- Oversee and monitor the application and effectiveness of the Institute's academic quality
 assurance system, including the provision of advice on the policies and operating procedures
 that support it.
- Evaluate the services that support learning and teaching activities and make recommendations for continuous improvement to the Academic Board.
- Provide oversight of the Programme Academic Quality Committees
- Identify good practice within the Institute and promote its dissemination.
- Identify common themes of causes for concern within the Institute and make recommendations for their analysis and resolution.

Engagement

In undertaking this mahi members have been reasonably consistent in their attendance at the monthly QAB hui. It is the view of the Chair that engagement with agenda items has been more challenging. At times, members have appeared ill-prepared to engage in korero on the matter at hand.

Reflection

At its final hui of 2020, members of Te Poari Whai Kounga reflected on the extent to which the committee had delivered against its terms of reference.

Members reflected on the following matters:

- whether information received through reports and RAG sheets provides sufficient information for the committee to have adequate oversight of processes aligned to it
- The need for further consideration of the work needed on student evaluation of courses.
 While the results belong with Ako Ahimura, the response and quality system support should be with this committee
- Recommendations and support from this Committee has resulted in significant improvements for some processes, like moderation.
- There is a need to enhance the sharing of good practice amongst schools
- There was limited oversight of stakeholder feedback except for through the Industry/stakehodler Risk Register and the Academic Risk Register
- Te Komiti's efficiency was hindered at times by the volume of items included for each meeting. More time for required to allow for robust discussion.
- There is a need to have/review end to end oversight of delivery to ensure the alignment of delivery (assessment) and graduate profiles.
- The need to ensure that approved recommendations (memos, etc.) to address issues are implemented to the expected standard and that the committee has oversight of this.
- The need to identify better approaches to communications flow, ensuring that information is received by relevant stakeholders

Next Steps

Te Komiti Whai Kounga will consider the above mentioned matters its first hui of the year to determine the most appropriate actions in each case.
