4.2.2. Consistency Review

Te Poari Whai Kounga discussed the report and noted that:

- One more review is due this year (24 November 2020) for the NZCE4 programme
- Four of the reviewed programmes got Excellent on the final report outcome (NZCRE, NZCLD, NZCME and NZCSP)
- Reports from Bridgepoint were sent to NZQA ahead of schedule
- Marginal status for some programmes is due to the difficulty in getting graduate outcomes
- TKK support is well received by schools

Te Poari Whai Kounga noted that a mechanism does not exist for good practice to be shared among schools and suggested that:

A seminar-workshop could be conducted

- Sharing could occur through PAQCs
- There could be an annual review process

- Completion checks have been completed on 80% of the expiring programmes
- 47% of the 1298 student checks have been completed in the system and the remaining remain in the books as these students are active in other programmes
- AAQs continue to check and complete students. However, at this time, AAQs will
 focus on posting grades and process completions for active programmes.
- Focus on providing support to schools and APMs specially for historical cases

- There was no change in the risks and ratings earlier identified

- Of the 80 programmes, 52.8% are rated low risk
- Highest level of risk among schools was recorded for Computing, Electrical and Applied Technology
- Key risk areas include:
 - Declining EFTS
 - o Insufficient resources (spaces and consumables) for programmes
 - Programme targets not met
 - Staff capability/capacity does not meet learner needs

5.1. Ētahi Kaupapa Anō | Any Other Business (AOB)

TOPIC: How well is the Committee achieving its Terms of Reference?

Te Komiti responses, issues and concerns raised include:

- Whether information received through reports and RAG sheets provides sufficient information for the committee to have adequate oversight of processes aligned to it
- More work needed to be done on student evaluation of courses. The results belong with Ako Ahimura but the response and quality system support should be with this committee
- Recommendations and support from this Committee has resulted in huge improvements for some processes like moderation. Good practice should be shared amongst schools
- Not much of an oversight of stakeholder feedback except for an Industry Risk Register
- Te Komiti's efficiency can be hindered by the volume of items included for each meeting. Need more time for more robust discussions

Actions needed:

- Ako Ahimura and Te Poari Whai Kounga need to review their end to end oversight to
 ensure graduate profiles align with assessments, as part of the moderation process.
 This should be owned by the programmes, with support from TPA, TKK and
 quidance from this committee.
- Te Poari Whai Kounga to identify systemic issues, review quality management systems, identify and address gaps, if any.
- Ensure that approved recommendations (memos, etc.) to address issues are implemented to the expected standard.

 Address gaps in communications flow. How does the information filter down to relevant stakeholders.
