Te Komiti Whakahaere a ngā Pia Terms of Reference

a) Purpose

To oversee the institute's postgraduate Level 9 and 10 quality systems, to identify areas of good practice and areas for improvement and monitor academic quality issues and trends.

b) Kaupapa

The Postgraduate Research and Scholarships Committee is framed within the values of Kaitiakitanga for the Academic Portfolio and Academic Quality and Mahi Kotahitanga and Ngākau Māhaki for its support of the Level 9 and 10 programmes. The Postgraduate Research and Scholarships Committee is accountable to the Academic Board for ensuring appropriate standards and quality are maintained at Level 9 and 10.

c) Membership

Membership of the Postgraduate Research and Scholarships Committee shall comprise:

- Director, Research and Enterprise
- The Academic Leader of each Postgraduate Programme;
- General Manager, Student Success or nominee;
- The Director, Māori Success or nominee;
- The Director, Pacific Success or nominee;
- One member of the Student Council nominated by the Student Council
- Members, mostly drawn from the academic community, co-opted by the Sub-Committee for a term as required; and
- Members co-opted by the Academic Board for a term as required.

The term of office of appointed members shall be one year.

Appointments shall be made to the Committee at or before the February meeting of the Academic Board each year.

The Chair of the Committee shall be the Director, Research and Enterprise.

d) Terms of Reference

The Postgraduate Research and Scholarships Committee (PGRSC) is a subcommittee of the Academic Board and has the following powers and functions in relation to Level 9 and 10 Masters and Doctoral programmes:

- Approve proposals for Level 10 theses;
- Oversee the processes of the approval of proposals for Level 9 research having 90 or more credits and confirmation of supervisory arrangements (including replacement supervisors);
- Approve registration of supervisors;
- Appoint examiners, conveners and adjudicators for Level 9 research having 90 or more credits and Level 10 research, on the recommendation of the Academic Leader;
- Consider the reports of examiners and declare and approve the final grade for a Level 9 research having 90 or more credits and Level 10 research;
- Award and oversee the administration of Postgraduate Scholarships; and,
- Make recommendations to the Academic Board on changes to the Generic Regulations affecting Postgraduate Programmes as necessary.

e) Reporting

The Postgraduate Research and Scholarships Committee shall report to the Academic Board following each meeting.

Recommendation

That the Committee welcomes Dr Hinekura Smith and discusses the integration of her Kaupapa Maori expertise into the programmes that offer Masters degrees at Unitec. Professor Jenny Lee-Morgan will join the committee for this discussion.

Information/Background

This appointment emerged from the work of the PGRSC in September 2020-agenda item 16 (memo attached), looking at challenges in the Level 9 &10 postgraduate programmes from a student perspective. Professor Jenny Lee-Morgan and Associate Professor Marcus Williams presented a business case to the executive last year and this appointment is the outcome.

Purpose

Dr Hinekura Smith joined Unitec in June this year as the Māori Supervision Adviser and is now joining the PGRSC. She will be able to provide Kaupapa Māori supervision to some Māori students as part of her role and she will also help grow the capacity of Māori supervision at Unitec .

The purpose of this agenda item is to provoke a discussion toward ensuring there is clarity in the professional relationship between the discipline supervisor and the Kaupapa Māori supervisor.

Purpose

 Resolve a significant shortfall of expertise at United which should be available to support students wishing to undertake Level 9 research utilising Māori or Pacific research methodologies and access Māori or Pacific knowledge.

Background

There has been a lack of expertise in Māori and Pacific research and research methodologies at Unitec for some time which has been exacerbated by disruption of programmes in the last five years. Unitec has announced a strategic focus on improving Māori and Pacific success and retention which is already increasing the numbers of these students in Level 9 study and will continue to do so. Leaders of Level 9 programmes, supervisors and students have been for some time expressing concern about the pressure to find appropriate expertise and the lack of human resource therein. Consultation has occurred with the Directors of Māori and Pacific Success, the staff in MAIA, the Director of Ngā Wai a te Tūī and the Unitec Te Tumu, Executive Director Student Success. The recommendations above came out of these consultations and are presented here for the committee to consider.

This memo is intended for providing an update from the Working Party comprising of Assoc Prof Marcus Williams, Cynthia Almeida and Hamza Qazi on the review of the Masters generic regulations.

Marcus has been advised by Steve Marshall to hold off implementing any changes to the existing regulations unless they are deemed critical for student success. A centralised position is coming from Te Pūkenga and a consultation process will be initiated soon with reference to postgraduate programmes.

Information/Background

The review is conducted annually to ensure that the regulation is up-to-date with the current practices and accommodating the changes that occurred in the past year.

Key Points

Terms of References for the review of Masters Generic Regulation:

- Review of various clauses and redefining their statements to capture the dual total Programme credits of 240 or 180 credits. These include, but are not limited to, clauses related to;
 - 1. The registration period for full time and part-time arrangements
 - 2. Suspensions & Extensions
 - 3. Honours
- Review of the nomenclature used and amend any which have been changed after the last review of the document.

The Working Party recommends the following changes in the Masters generic regulations:

1. Clause c & d under Whakaurunga Takiwā | Enrolment periods

- c. Where a candidate is enrolled full-time throughout the period of their registration, the maximum period of registration for the award of the degree with honours is six semesters for 240 credits programme and five semesters for a 180 credits programme;
- d. Where a candidate is undertaking the degree by part-time study, the maximum period of registration for the award of the degree with honours is ten semesters for 240 credits programme and eight semesters for a 180 credits programme; this period being reduced to account for periods of full-time study

2. The registration period for full time and part-time arrangements

The Committee noted that the registration time for a 240 credits programme and a 180 credits programme, to be eligible for honours was inequitable and hence recommends the following change:

Whakaurunga Takiwā | Enrolment periods

- i) 'that Clause c. which currently states "Where a candidate is enrolled full-time throughout the period of their registration, the maximum period of registration for the award of the degree with honours is 36 months" be changed to:
 - Where a candidate is enrolled full-time throughout the period of their registration, the maximum period of registration for the award of the degree with honours is six semesters for 240 credits programme and five semesters for a 180 credits programme
- ii) that Clause d. which currently states "Where a candidate is undertaking the degree by part-time study, the maximum period of registration for the award of the degree with honours **is 60**months; this period being reduced to account for periods of full-time study" be changed to

"Where a candidate is undertaking the degree by part-time study, the maximum period of registration for the award of the degree with honours is ten semesters for 240 credits programme and eight semesters for a 180 credits programme; this period being reduced to account for periods of full-time study"

3. Suspension and Extension of Candidature

If the term 'suspension' can be changed to a more positive term

4. Honours

- a. If honours could be based on the research component only and not in combination with course grades
- b. Can the honours calculation method be applied to programmes with a research component of only 45 and 60 credits
- c. If the term Honours (2nd) be changed to just 'Honours' and Honours (1st) remain unchanged.
