Te Komiti engaged in korero over the evaluative feedback comments and responses, and deliberated on the details of approval and the programme rating. Key points included:

- Clarification between the credit values of the programme (121) and the qualification (120); the pros, cons and rationale for the difference; and possibilities for improvement and alignment of the values for when the qualification is next reviewed.
- Clear wording of Learning Outcomes such as changing from "Safely isolate AC circuits" to "Demonstrate isolation of AC circuits" so that greater emphasis is placed on the ability to measure the outcome.
- Lack of evidence of broad stakeholder consultation and summaries of what was discussed in the consultations.
- Lack of evidence of transition planning
- Suggestion to make the number of Learning Hours to be "indicative".

1015h: Mirjana Bogosanovic (Programme Team representative) entered the meeting to respond to matters raised in evaluative discussion. She provided additional context to the operations of the consortium that Unitec is collaborating with to develop the programme. Mirjana departed at 1035h.

Te Komiti deliberated and agreed that the application was not ready for unconditional approval, noting that although adequate consultation may have occurred in the development of the Level 4 version of the programme by the Skills ITO and some parts of that may be relevant to this Level 3 programme, evidence of specific support for this Level 3 programme was required. Te Komiti felt that it was important to support the School in presenting the concerns of Te Komiti to the consortium of developing ITPs.

 New Zealand Certificate in Electrical Pre-Trade (Level 3) (Level 3, 121 Credits)

Subject to fulfilment of the following requirements by **2021-08-31**:

- Programme Approval: Good evidence the programme is made up of learning outcomes structured in a
 coherent way to achieve the qualification outcomes and addresses the relevant needs of learners. The
 structure of a number of the learning outcomes appear as topics or tasks rather than stating a clear,
 measurable outcome for the learner.
- 2. Programme Approval: Good evidence the programme is acceptable to the relevant communities and key stakeholders, which includes the qualification developer and industry. While there is evidence of collaboration with the qualification developer, there is little evidence provided from wider industry and other stakeholders, including Māori, with regards to the ability of the programme to meet the requirements of the qualification.
- 3. Programme Approval: Addition to Course Descriptors of a statement to link back to the Assessment Methods (i.e. theory/practical too loose). Denote the specified assessment method that will be used under the theory/practical.
- 4. Programme Accreditation: Appropriate transition arrangements to be provided for students of the current programme to transition into the new programme. It was noted that individual ITPs would need to undertake this mahi.
