The Chair updated Te Komiti on discussions between Unitec and other state departments regarding most-likely plans for delivery of teaching and learning for the remainder of 2021, including how to manage SAC funding, EFTS allocation, student loans, HAFL and bulk approvals for responsive programme changes post-factum. MIT and Unitec are working to align their approaches. As decisions are confirmed, communications should go out to learners. All possible efforts are being made to shield learners from negative impacts.

2. Mea Hei Whakaae | Items to Approve / Endorse

2.1. Revisions to the Admission and Enrolment Procedures

Presenter: Martin Carroll

- This matter arose out of the work of Project Mānawa Tina and discovery of procedural elements which do not meet regulatory requirements.
- Change 1: No-Shows are processed on a course, not programme, basis.
- Change 2: The No-Show deadline is the end of the first 10% date or 30 days whichever is sooner.

Te Komiti interrogated the changes and understood the importance and urgency of the correction to the Procedure, noting that a procedure of this type would usually come up via Quality Alignment Board. However, in this case it has significant and extant legal and compliance issues. The approving body for the Procedure is actually ELT. Due to the importance and urgency of the matter, this correction has already been approved by ELT and is being presented to Te Komiti for courtesy post-factum. Chair emphatically clarified that the previous version of the Procedure was non-compliant. This is to correct a mistake with monetary implications.

- d) accessed Moodle or any of the electronically based class material after the Class Start Date.

ACTION: Liz Rainsbury to lead a Working Group to review the fairness of 18.2.d) with a view to present proposed changes via Quality Alignment Board and / or Ako Ahimura back to Te Komiti Mātauranga. Consultation is expected to occur with legal, TEC and Student Council representation due to being attached to funding conditions. Interested members should contact Liz Rainsbury to contribute.

All actions are progressing without unexpected concerns. Under the reporting for Te Pae Tawhiti, the Internal Champions are Toni Vaughan and Simon Nash. Consultation is underway with MIT and multiple other stakeholders to change the target date for parity of EPI outcomes from the end of 2022 to the end of 2024 due to the negative impact of Lockdowns.

4.1.3. International Success

Te Komiti discussed heightened risks associated with the academic progress of International learners, especially how extended periods of online learning are a struggle. Mitigations include the tracking and monitoring of all International learners and contacting high risk learners each week.

Unitec is acting to apply the International Strategy from Te Pūkenga to the local context. Collaboration is underway with Marketing toward a stretch target of 120 EFTS for new enrolments in 2022.

NZQA has clarified that 2022 compressed course delivery will not be allowed for any courses with International enrolments.

Work is underway to improve the system, but resources are highly constrained especially with the support available from Te Korowai Kahurangi data analyst workloads.

Te Komiti noted that recent Unitec Student Council (USC) mahi includes the following areas.

- International students and visa implications due to Lockdowns
- Increased student voice in decision-making across United
- Pfizer jab campaign at Unitec modelled on those at Otago University and NorthTec
- Improving access by learners to the Hardship Fund for Learners (HAFL)
- Closing out project of 2021 and handing over to the incoming USC members of 2022
- 2021 was a very challenging year for USC for various reasons, especially Lockdowns

- Kevin Toto, as the new Student President, is undertaking to develop connections across Unitec.
- The Pacific Representative has established the Pacific Association and is recruiting members. The
 Association expects to assist with reaching parity EPI targets and community development.
 Collaboration is underway to upskill from the governance capabilities of Te Ropu Mataara.
- Discussion is happening within USC to add representation of Under-25 and Disability.

Te Komiti commended Kevin Toto for the quick response to appointing student representatives to the three Research committees, namely UREC, URC and PGRSC, and commended USC in general for their organisation and activities especially in thinking forward to 2022.

- Te Puna Ako response to EER Recommendation 7 A large amount of feedback has been received. The aim is to present a memo to the next hui of Ako Ahimura and then endorse it to Te Komiti Mātauranga for approval.
- Learning and Teaching Business Continuity Plan Learnings from the Lockdowns of 2021 are
 informing an updated draft with the aim to increase robustness and forward-thinking. This will come
 up to Te Komiti Mātauranga for approval. To improve readability, summary pages will be developed
 for each section of the Plan. Clear and consistent messaging to staff is very important. The Plan is
 originally based on a similar plan from MIT. The updated Plan will be compared with the updates to
 the MIT equivalent.
- Changes made to assessment should be captured and approved as permanent alternate
 assessment paths in the Programme Approval Documents so that they can be ready for activation
 in the event of future Lockdowns or other disruptions. NZQA has expressed support for this idea.
- Ako Ahimura has discussed the Review of Teaching Excellence Awards and reporting on New Teacher Inductions.

- Consistency Reviews No significant concerns. Data collection practices are being improved.
- Degree Monitoring The need to separate the monitoring of Architecture programmes from their Professional Accreditation visits is currently being worked through with the School.
- Programme Development Activity has been adjusted in accordance with the recent ELT directive. Updates on the two red-rated programmes include:
 - BAT This originally small development grew into a larger change. Work went off track, the development has been cancelled by ELT and the item will be deleted from the next iteration of the tracker.
 - BPSA This development is currently with NZQA and is expected to receive approval in due course.

- A roadshow presentation of RoVE updates to United staff could be useful.

- How RoVE developments may affect the Tāmaki-Makaurau Strategy are yet to be confirmed.
- Institutional capacity to undertake BAU is a concern in view of the impact of continued and repeated Lockdowns and calls from Te Pūkenga for contributions planning and development mahi.

- Two workstreams are being set up, namely for the Academic Regulatory Framework and Academic Quality Framework.
- A working group is being established for the Ako Framework which was to be a central design team but will now take a distributed approach instead.
- The development of the Digital Strategy is now being now brought inhouse to Te Pūkenga.
- Te Pūkenga continues to draw in more staff from Unitec to various Working Groups.

ACTION: Chair Martin to consider pluralizing this agenda section to cover all Working Groups commissioned by Te Pūkenga which directly relate to the Terms of Reference of Te Komiti Mātauranga.

4.4.3. EER Action Plan

4.4.4. Combined Student Complaints Report 2021-Q1 and 2021-Q2

Presenter: Annette Pitovao

Te Komiti noted the year-on-year increase in complaints compared to the same period in 2020 and the emergence of themes and trend which will be analysed and responded to in due course.

Te Komiti discussed concerns on the impact to learners from Lockdowns.

- Study workloads remains unadjusted in the midst of Lockdown effects, e.g. overcrowded houses; inability to concentrate in a home environment; inaccessible technical resources.
- Teachers are not trying to make it harder, but the Lockdowns have unavoidably increased pressures for learners.
- Many learners rely on face-to-face as their core learning style which under Lockdowns goes missing and heavily impacts their ability to succeed.

Te Komiti also noted the following points.

- Learning Advisors (formerly Academic Development Lecturers) are helpful, but often cannot provide necessary discipline-specific knowledge.
- The 14-day extension to Affected Performance Considerations has been helpful.
- Cutbacks and Lockdowns have reduced the capacity of staff to act as complaint investigators.
