### **1.3              Te Komiti Whakahaere a ngā Pia Terms of Reference**

#### **a) Purpose**

To oversee the institute's postgraduate Level 9 and 10 quality systems, to identify areas of good practice and areas for improvement and monitor academic quality issues and trends.

#### **b) Kaupapa**

The Postgraduate Research and Scholarships Committee is framed within the values of Kaitiakitanga for the Academic Portfolio and Academic Quality and Mahi Kotahitanga and Ngākau Māhaki for its support of the Level 9 and 10 programmes. The Postgraduate Research and Scholarships Committee is accountable to the Academic Board for ensuring appropriate standards and quality are maintained at Level 9 and 10.

#### **c) Membership**

Membership of the Postgraduate Research and Scholarships Committee shall comprise:

- Director, Research and Enterprise
- The Academic Leader of each Postgraduate Programme;
- General Manager, Student Success or nominee;
- The Director, Māori Success or nominee;
- The Director, Pacific Success or nominee;
- One member of the Student Council nominated by the Student Council
- Members, mostly drawn from the academic community, co-opted by the Sub-Committee for a term as required; and
- Members co-opted by the Academic Board for a term as required.

The term of office of appointed members shall be one year.

Appointments shall be made to the Committee at or before the February meeting of the Academic Board each year.

The Chair of the Committee shall be the Director, Research and Enterprise.

#### **d) Terms of Reference**

The Postgraduate Research and Scholarships Committee (PGRSC) is a subcommittee of the Academic Board and has the following powers and functions in relation to Level 9 and 10 Masters and Doctoral programmes:

- Approve proposals for Level 10 theses;
- Oversee the processes of the approval of proposals for Level 9 research having 90 or more credits and confirmation of supervisory arrangements (including replacement supervisors);
- Approve registration of supervisors;
- Appoint examiners, conveners and adjudicators for Level 9 research having 90 or more credits and Level 10 research, on the recommendation of the Academic Leader;
- Consider the reports of examiners and declare and approve the final grade for a Level 9 research having 90 or more credits and Level 10 research;
- Award and oversee the administration of Postgraduate Scholarships; and,
- Make recommendations to the Academic Board on changes to the Generic Regulations affecting Postgraduate Programmes as necessary.

e) Reporting

The Postgraduate Research and Scholarships Committee shall report to the Academic Board following each meeting.

### **Purpose**

The PGRSC has \$250k of scholarships to allocate to programmes, priority groups and contestable frameworks.

### **Background**

The figures allocated need to be decided in August so that leaders can utilise the resource to publicise their programmes, Māori and Pacific Success directors can support priority group students and the call for expressions of interest for the Industry Scholarships and the Bold Innovators can be circulated.

Data on past years EFTS and scholarship allocations have been presented to the committee with proposed figures for 2022. These latter are primarily based on EFTS (full data provided), with some consideration of the uptake of scholarships in the previous year and opportunity to grow programmes.

Leaders of programmes are asked to consider the overall benefit of these scholarships to all Unitec students in the spirit of collaboration and within the context of Manaakitia te Rito; the Unitec Strategy and Te Noho Kotakitanga.

### ***NB - Level 9 Proposals Approval Committee Membership criteria***

*The committee must adopt the guidelines for the submission and approval of student research proposals as outlined below.*

1. *There must be at least four academics on the committee.*
2. *The committee will be a stand-alone committee and not a sub-committee of another committee.*
3. *Membership must collectively address the following criteria:*
  - a. *Members must be on Unitec's Register of Supervisors (with at least one principal supervisor who must have a qualification equal to or greater than the level of the proposed study).*
  - b. *Membership would ideally consist of a network of qualified people who cooperate and share good practice throughout the institution.*

### **Recommendation**

To extend the membership of the PGRSC to include representatives from programmes that do not offer 90 or above credit thesis or dissertations as part of their postgraduate qualifications.

### **Rationale**

The rationale for this recommendation is as follows.

Schools with sub 90 credit postgraduate programmes will benefit from the discussion and material available through the PGRSC.

1. While some schools do not offer 90 or above credit research projects, they are still involved in the research community and will therefore benefit from being part of the PGRSC.
2. Schools with postgraduate programmes should be part of the ongoing review process of postgraduate regulations
3. Schools with sub 90 credit research projects are still required to follow supervision guidelines and regulations for quality assurance purposes.
4. Schools with sub 90 credit research projects are still required to be research active
5. Schools with sub 90 credit research projects may still be required to apply for ethics approval

6. Schools with sub 90 credit research projects may have staff and students who may participate in Unitec's research seminars and conferences.
7. Schools with sub 90 credit research projects may have students who qualify for the scholarships being offered through the PGRSC

### **Background**

The PGRSC is a postgraduate forum tasked with the oversight of postgraduate qualifications at Unitec with particular attention to the Thesis/Dissertation component. The oversight responsibilities include the following;

- Management and coordination of scholarships
- Maintenance of supervision register (part of the quality assurance process)
- Monitoring the research activity of supervisors
- Coordinate the professional development of supervisors
- Liaise with the ethics committee in relation to postgraduate research

The PGRSC is the committee that brings stakeholders together to discuss the above issues insofar as they apply to Level 9 &10 programmes at Unitec.

At the moment programmes that do not offer a 90-credit thesis or above are not part of the committee.

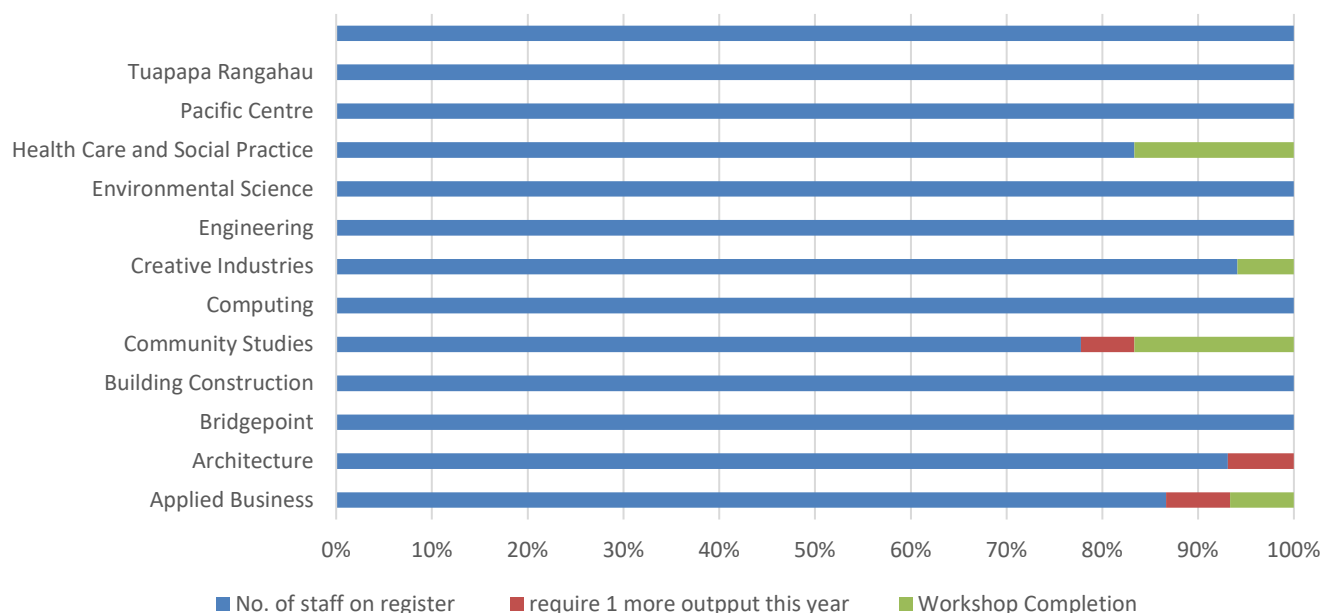
